COVENANT OF SUPPORT
July 1, 2012 - June 30, 2013

1. **Payment of Full Tuition:** The Family must pay Full Tuition commensurate with the established Tuition Rates. Payment options are available, but tuition must be **paid in full by May 31, 2013.**
2. **Parishioner Status Tuition Rate vs. Non-Parishioner Status Tuition Rate:** Parishioner Status means that the Family is registered at Sacred Hearts Parish (Bradford-Groveland), worships at Sacred Hearts Parish (Bradford-Groveland), and contributes a minimum of \$400 (which amounts to \$6.00/week for 52 weeks + \$88 to Grand Annual Collection for SH Parish) to the Parish via the regular (not special collection) weekly Offertory Envelope system (which requires the family to have a Numbered Envelope). *Families who do not register with the Parish OR who are non-Catholic are considered Non-Parishioners and are required to pay the Non-Parishioner rate.*
3. **Calendar Raffle Commitment:** The Family is responsible for selling/purchasing **twenty** (\$10) Calendar Raffles. The total amount due is **\$200 by December 20, 2012.**
4. **Family Volunteer Hours:** At least one parent/guardian PER FAMILY is responsible for serving **20 VOLUNTEER HOURS OF SERVICE.** (Opportunities described in the Events & Activities Guide & The Principal's Newsletter.) A family may choose to waive the 20 hours and pay \$400 in lieu of volunteering. If so, payment IN FULL is due by August 1, 2012. Note: Families who choose to volunteer, but do not fulfill their 20 hours will be billed at a rate of \$20 per missing hour.
